Annual Letter

from **Christopher Purdy**



In 2024, DKT provided a record-breaking 67.3 million Couple Years of Protection (CYPs) empowering millions to take control of their sexual and reproductive health and shape their own destinies. In the pages that follow and on our website, you will find details, data, and research that highlight the massive and transformative health impact that DKT provides to individuals in more than 100 countries.

I want to use this annual letter to share a few thoughts on how DKT is addressing the incredible challenges currently facing reproductive health. We are in a period of geopolitical uncertainty and incredible disruption impacting reproductive health and foreign assistance funding. Conservative groups and governments are strategically attacking the freedom of individuals to determine their own reproductive choices. Digital censorship by large tech companies and orchestrated misinformation campaigns systematically curtail access to accurate sexual health information. The illegal dismantling of USAID and the probable shifts in European donor funding towards military preparedness means more competition for fewer overseas development funds. Vulnerable and marginalized groups bear the brunt of this turmoil.

Amidst this upheaval, **DKT International stands strong. We continue our well-established service delivery work** bringing a wide range of high-quality, affordable products and services to people who want them — and educating and empowering people with the information they need to make informed choices. **We are one of the largest providers of contraceptive and safe abortion information, products, and services in the world** — and deliver cost-effective impact at scale. In addition, we increasingly see our role as a sustainable ‘enabler’ of reproductive health ecosystems. For example, in 2024:

- **We trained and detailed more than 846,680 health professionals** in both the private and public sectors; this capacity building helps elevate the overall quality of health systems.
- **DKT launched 61 new products across 34 countries**, developing markets by introducing new technologies, including hormonal implants in Afghanistan, intrauterine devices (IUDs) in Burundi, and mifepristone in Nicaragua.
- **We supported governments as they grapple with contraceptive security issues:** DKT established an IUD repacking plant in Pakistan and is the sole importer of IUDs into that country; **DKT WomanCare delivered 8 million injectable contraceptives** to the Ethiopian Ministry of Health at highly competitive prices, providing value for money.

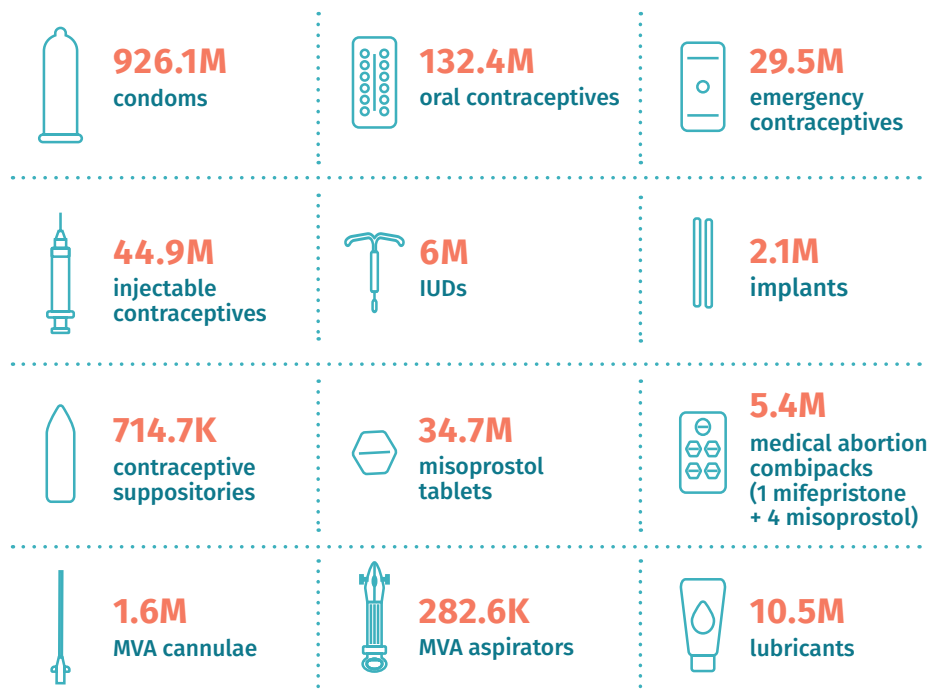
DKT represents a terrific investment for donors. We continue our journey towards increased self-reliance so the bulk of costs (including most overhead and commodity costs) are covered by sales revenues. Donor funds are therefore efficiently used to support work on the ground — serving vulnerable and last-mile groups, developing educational campaigns to empower young people, and covering start-up costs for innovation. DKT’s lean head office of 13 people means that HQ expenses are 1.7% of budget — and fundraising costs are only 0.2%.

All of this gives me hope — and I hope it does for you as well. We are committed to serving those who rely on DKT while expanding our reach to even more people worldwide. **DKT was purpose-built and has the passion and grit to weather the challenges of our times. Your support is much appreciated — and needed.**

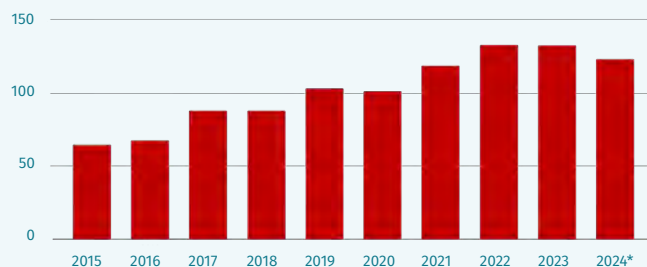
DKT trained and detailed **846.7K health care providers** in 2024



DKT builds the capacity of physicians, midwives, pharmacists, and drug shop attendants on a routine basis to ensure that clients receive high-quality, judgement-free care. Training topics include insertion and removal of IUDs and implants, how to manage side effects, counseling for young people, and business-related skills such as inventory management and cash flow.

More than 90% of DKT's commodity procurement is financed by DKT's own sales revenues. This allows DKT to most effectively leverage donor support to reach the last mile and advance our health equity goals, ensuring clients across income levels can afford high-quality products.

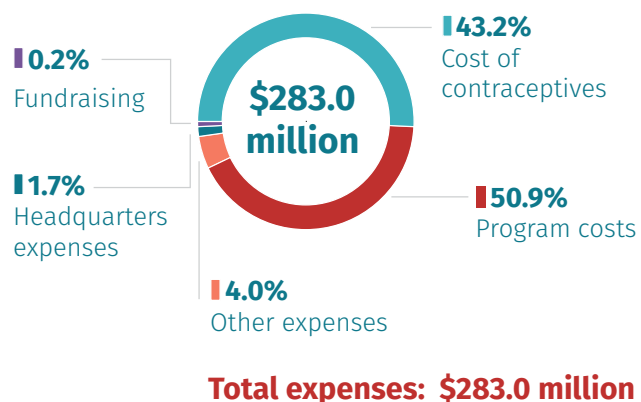
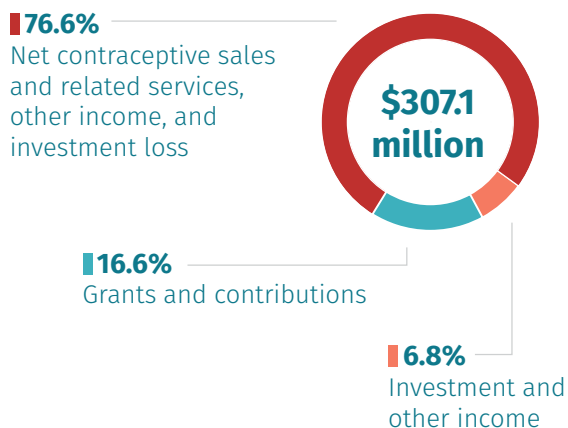


DKT WomanCare is a leading supplier of reproductive health products, marketing and distributing Levoplant contraceptive implants, Ipas manual vacuum aspiration (MVA) technology, contraceptive injections, emergency contraceptive pills, oral contraception, intrauterine devices, and medical abortion pills across 90 countries. DKT WomanCare is the legal manufacturer of the Ipas MVA kit technology and works closely with global procurement agencies, governments, NGO partners, and commercial distributors to expand access to high quality reproductive health products.
